Endocrine Agents	Armour Thyroid (dessicated) (NF)	Levothyroxine Sodium (2), Levoxyl (2), Synthroid (4)

Non-Cox-Selective NSAIDs	Indomethacin (NF)	Suggested for short-term use
	Ketorolac (NF)	Ibuprofen (1,3), Meloxicam (1,4), Naproxen (1,2,3,4), Celecoxib (4); Etodolac (4)
Sulfonylureas, Long Acting	Chlorpropamide (NF), Glyburide (NF)	Glipizide (1), Glimepiride (1), Metformin (1)
Skeletal Muscle Relaxants	Carisoprodol (NF), Cyclobenzaprine (4), Methocarbamol (NF), Metaxalone (NF), Chlorzoxazone (NF), Orphenadrine (NF)	Baclofen (2), Tizanidine (2)
